64/2012 PUBLIC PARTICIPATION

64.2012.1 Public Speaking

Alcohol Free Zones - PC Stokoe informed the meeting that there are some alcohol free zones, but they lack the signage needed to make them enforceable. He would check with AVBC and get Dawn Lawrence to contact the Parish Council and he would also discuss signage with her.

High Street seems to be an area where youngsters congregate.

The question was asked if the All Weather Pitch could become an alcohol free zone, with it being on private land. PC Stokoe said that he believed it could, as alcohol free zones can only apply to outside area not inside buildings.

Sleetmoor Lane Speeding – motorbikes have been caught speeding down Sleetmoor Lane, PC Stokoe would contact colleagues about speed equipment.

Crays Hill seems to be a lot better lately, 6 children have received letters about their behaviour and patrols have been redirected there because of this behaviour. 4 children have received £30 tickets regarding brakes/reflectors etc. Parents have been supportive of this action. It is not illegal to not wear a helmet – many schoolchildren don't wear helmets. The police will print leaflets on road safety and take these into the schools.

Police issued 80 tickets a few weeks ago, for motorists using mobile phones, not wearing seat belts and so on.

Scooters don't come under legislation unless they are used on the carriageway.

Parking, Pentrich Road – most parking powers have been taken away from the police, however, warning notes have been left on some cars. The Civic Enforcement Officers' have also attended this area.

The Chair thanked PC Stokoe for his attendance, and he left the meeting.

Derbyshire County Councillor David Wilson

Spoke about Sleetmoor Lane and his requests for police to attend regarding speeding vehicles.

Cllr Wilson is putting £1300 into a kids/bicycles project – this is being run through the police force, and he doesn't want Swanwick children to be left out. The course teaches children cycle maintenance/road safety – children don't have to have a bike, if they complete the course they will be given one. The Police are administering this course and advertising it. The question was asked if the money could be used to fund helmets, which is very important.

Housing Options for Growth – Cllr Wilson informed the meeting that he would represent Swanwick's views at County Council.

Proposed Crematorium – Cllr Wilson would be attending the exhibition tomorrow and he asked to be advised of the Parish Council's decision when it is made.

The Chair thanked Cllr Wilson for his attendance and he left the meeting.

Members Observations:

Cllr Fretwell asked about future meetings being held at Swanwick School & Sports College.

Questions were also asked about the response to the Parish Council's letter to AVBC regarding Swanwick Hall Cricket Club, as yet a response has not been forthcoming. It was decided to contact Cllr Jack Brown to see if he could initiate some response.
